### **Applying for Grant of Probate and Administration of Estate**

Our hourly rate for such matters is £200 (inclusive of vat).

If you appoint ourselves as professional executors of the will by the executors, we will charge between 1.0% to 2.5% of the gross value of the estate in addition to the hourly rate.

We think this will take between 10 and 25 hours of work at £200 (inclusive of vat).

The exact cost will depend on the individual circumstances. Including whether there is

- If there is a valid will
- Number of beneficiaries
- No disputes exist between the beneficiaries
- Whether inheritance tax needs to be paid or not and whether forms need to be submitted to the HMRS, Form IHT 400 or others
- There being no claims made against the estate by others
- Number of assets, within the estate, properties, bank accounts, share etc

### **Possible further costs and disbursements**

For example, should there be no will or the estate has included in it shares or properties that need to be valued, sold or transferred, or we have to deal with the DWP or HMRC to deal with benefit over payments, income tax relating to the deceased or the estate.

We can only provide you information of these costs and disbursements and VAT once we are fully aware of all the circumstances.
